Eglin AFB Outdoor Recreation Violation & Privilege Revocation System Fish & Wildlife Violations

1 Oct 21 - 30 Sept 22

Forfeiture of collateral and mandatory appearances for offenses committed within the boundaries of the Eglin AFB within the Northwest District of Florida, as of March 4, 2013 by order of Rule 3(b) by Judge Elizabeth M. Timothy, United States Magistrate Judge.

NOTICE TO OFFICERS:

When determining the length of suspension for infractions, please consider that in some instances a warning may be as effective as a suspension in altering behavior while at the same time protecting the resource and promoting recreational activities.

Eglin Revocation System

Warning: Written warning issued, does not count as 1st offense.

1st Offense: If this is the individuals first offense or the first offense in the past 5 years the individual is given the suspension period and fined as stated in this document.

Example: The individual is caught after hours, violating a Government Imposed Burn Ban, and cutting tree without a permit. The individual receives the NOVAA for the 6 month suspension for Trespass Before/After Legal Hours and the \$55.00 fine for the violation. Note: The more severe of the violations is chosen when there are multiple offenses.

2nd Offense: If this is the individuals second offense or the second offense in the last five years the suspension time is doubled and fined as stated in this document.

Example: The individual above serves his 6 month suspension for his 1st Offense and is caught in possession of a gun/bow after legal hunting hours. A charge which is normally 1 year and a \$55.00 fine but, this is his second violation within a 5 year

period. His charge is doubled to 2 years and is fined \$55.00 for the violation.

3rd Offense: If this is the individuals third offense or the third offense in the last five years the suspension is an automatic 5 years and the fine as stated in this document.

Example: The individual above serves his two year suspension and is caught transporting live wildlife. A charge which is normally 1 year but, this is his third violation in a 5 year period. His charge is an automatic 5 year suspension from the Eglin

reservation.

Note: Any individual caught recreating on the Eglin reservation while under an active NOVAA suspension should be charged with:

"Trespass On Military Property After Removal or Ordered Not To Renter"
(5 Year Suspension)

Note: Monetary fines listed in this document cannot be altered. Second and subsequent offenders fines cannot be doubled.

Note: Depending on the severity of the offense(s) and blatant disregard for rules, an individual's recreation priveleges may be permanently revoked via disbarrment by order of the TW/CC.

Aggravated Battery	The crime of physically attacking another person which results in serious bodily harm and/or is made with a deadly or dangerous weapon such as a gun, knife, sword, ax or blunt instrument. Aggravated assault is usually a felony punishable by a term in state prison.
All-terrain Vehicle	An engine-powered vehicle with wheels or tracks of less than a 60-inch wheelbase measured from the center of the forward wheel or hub to the center of the rearmost wheel or hub.
Amphibians	All members of the class Amphibia (for example frogs, toads, mudpuppies, newts and salamanders).
Antlered Deer	Any deer having one or more antlers at least five inches in length visible above the hairline.
Antlerless Deer	Any deer, except a spotted fawn, that is without antlers or whose antlers are less than five inches in length visible above the hairline.
APR	Antler Point Restriction (Brier Creek & Jackson MU's). 4 points on a side (1 inch or better in length) or a main beam of 14 inches or better
Assault	the threat or attempt to strike another, whether successful or not, provided the target is aware of the danger. The assaulter must be reasonably capable of carrying through the attack. In some states if the assault is with a deadly weapon (such as sniping with a rifle), the intended victim does not need to know of the peril. Other state laws distinguish between different degrees (first or second) of assault depending on whether there is actual hitting, injury or just a threat. "Aggravated assault" is an attack connected with the commission of another crime, such as beating a clerk during a robbery or a particularly vicious attack. 2) n. the act of committing an assault, as in "there was an assault down on Third Avenue." Assault is both a criminal wrong, for which one may be charged and tried, and civil wrong for which the target may sue for damages due to the assault, including for mental distress.
Assault and Battery	The combination of the two crimes of threat (assault) and actual beating (battery). They are both also intentional civil wrongs for which the party attacked may file a suit for damages.
Battery	The actual intentional striking of someone, with intent to harm, or in a "rude and insolent manner" even if the injury is slight. Negligent or careless unintentional contact is not battery no matter how great the harm. Battery is a crime and also the basis for a lawsuit as a civil wrong if there is damage. It is often coupled with "assault" (which does not require actual touching) in "assault and battery."
Black Bass	Any Species of Bass in the genus Micropterus (Largemouth, Shoal, Suwannee, Spotted, and Choctaw Bass).
Bow	A device consisting of flexible material having a string connecting its two ends for the purpose of discharging arrows; which propels arrows only by the energy stored by the drawing of the device; which has a minimum draw weight of 35 pounds; which is hand-held, hand-drawn and hand-released; which is not equipped with a device that can mechanically hold the bowstring in the drawn (ready to fire) position; and which may include mechanical bowstring release devices provided they are only hand-held.
Bush Hook/Set Line	A single line with a single hook attached to a tree, bush, shore or other structure.
Closed Season	The calendar period during which the taking of freshwater fish or wildlife is prohibited.
Controlled Substance	A drug which has been declared by federal or state law to be illegal for sale or use, but may be dispensed under a physician's prescription. The basis for control and regulation is the danger of addiction, abuse, physical and mental harm (including death), the trafficking by illegal means, and the dangers from actions of those who have used the substances.
Crossbow	A device consisting of a bow affixed to a stock for discharging quarrels, bolts, or arrows and which utilizes a non-hand-held locking mechanism to maintain the device in a drawn or ready-to-discharge condition.
Daylight Hours	The time of day from one-half hour before sunrise until one-half hour after sunset.

Fawn Deer	The time of day from one-half hour before sunrise until one-half hour after sunset.
Firearm	Any weapon (including a starter gun) which will or is designed to or may readily be converted to expel a projectile by the action of an explosive; the frame or receiver of any such weapon; any firearm muffler or firearm silencer; or any destructive device. Such term does not include an antique firearm.
Fur-Bearer	Beaver, nutria, opossum, raccoon, skunk.
Gun	Shotgun, rifle, pistol, revolver, air gun, gas gun, blow gun, bow, crossbow, or any other device mechanically propelling an arrow, spear, or other projectile.
Legal Game	Antlered deer, gray squirrel, rabbit, quail, rail, snipe, woodcock, duck, dove, geese, coot and common moorhen during open seasons established for each species by Rule 68A-13.003, 68A-13.004 or 68A-13.008, F.A.C., unless otherwise stipulated for a particular species in a regulation established for a specific wildlife management area, wildlife and environmental area, public small game hunting area or public use areas.
Light	Any artificial light for use in taking wildlife or freshwater fish
Lotter/Prowl	A person commits the offense of loitering or prowling when he is in a place at a time or in a manner not usual for law-abiding individuals under circumstances that warrant a justifiable and reasonable alarm or immediate concern for the safety of persons or property in the vicinity.
Negligence	Failure to exercise the care toward others which a reasonable or prudent person would do in the circumstances, or taking action which such a reasonable person would not. Negligence is accidental as distinguished from "intentional torts" (assault or trespass, for example) or from crimes, but a crime can also constitute negligence, such as reckless driving. Negligence can result in all types of accidents causing physical and/or property damage. An added factor in the formula for determining negligence is whether the damages were "reasonably foreseeable" at the time of the alleged carelessness.
Open Season	The calendar period during which freshwater fish or wildlife may be lawfully taken.
Possession	The word "possession" whenever used in these rules shall mean any one of the following: (a) Manual possession. (b) Physical possession. (c) Control or custody. (d) Possession in one's clothing, attire or equipment. (e) Possession in or about a vessel, vehicle or beast of burden under one's custody or control, including but not limited to compartments, drawers, pockets, trunks, and similar places in and about such vessel, vehicle, or beast of burden.
Pre-charged pneumatic air gun	A commercially-manufactured air gun that is charged from an external high compression source such as an air compressor, air tank, or external hand pump and is specifically designed to propel a bolt, arrow, or other projectile commonly used for hunting.
Reptiles	All members of the class Reptilia (for example, alligators, caimans, crocodiles, turtles, lizards and snakes).
Resident game birds	Wild turkey and quail.
Small game	Game species other than deer, bear or wild turkey.
Take	The term shall include taking, attempting to take, pursuing, hunting, molesting, capturing, or killing any wildlife or freshwater fish, or their nests or eggs by any means whether or not such actions result in obtaining possession of such wildlife or freshwater fish or their nests or eggs.
Transport	Shipping, transporting, carrying, importing, exporting, receiving or delivering for shipment, transportation or carriage or export.

Wildlife Management Area (WMA)	An area of private or public ownership established for the management of wildlife or freshwater fish on which hunting, fishing or other outdoor recreation may be permitted only at such times and under such regulations as are specifically provided for each individual area.
