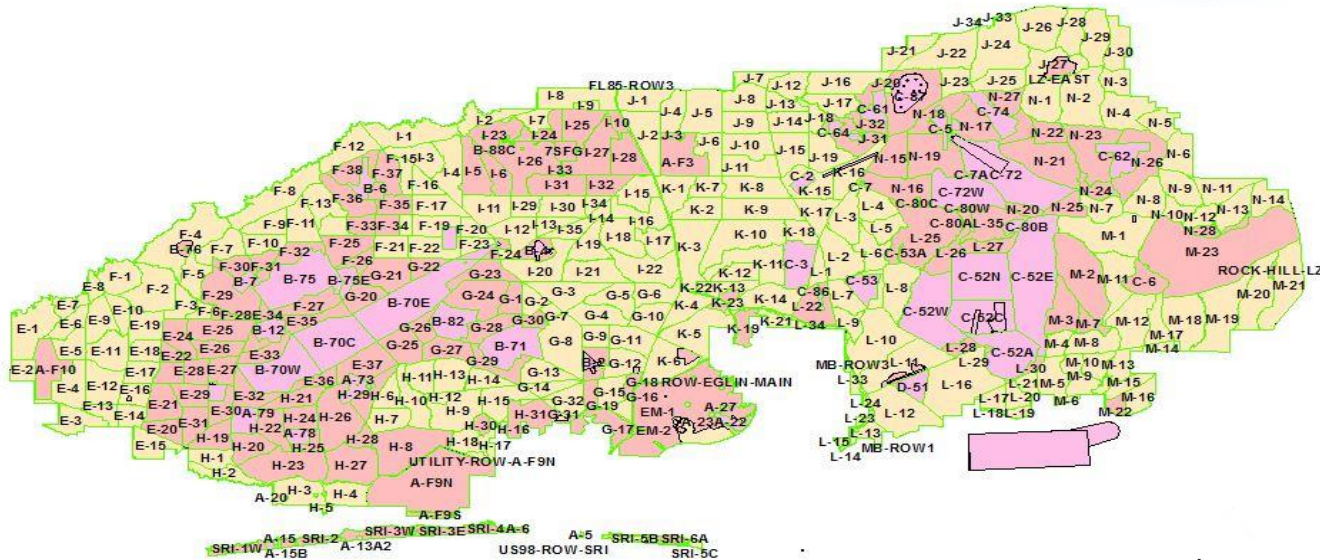




NOTICE OF VIOLATION AND ADMINISTRATIVE ACTION (NOVAA) CHARGE BOOKLET

Eglin AFB Outdoor Recreation Violation & Privilege Revocation System
Fish & Wildlife Violations

Forfeiture of collateral and mandatory appearances for offenses committed within the boundaries of the Eglin AFB within the Northwest District of Florida, as of March 4, 2013 by order of Rule 3(b) by Judge Elizabeth M. Timothy, United States Magistrate Judge.

Eglin Revocation System

- 1st Offense** - Fine and suspension period stated.
- 2nd Offense** - Suspension time doubled and the fine is as stated.
- 3rd Offense** - Automatic 5 years suspension.

Examples:

- 1st offense** - The individual is caught after hours in a closed area cutting a tree without a permit. The individual receives the NOVAA for the 1 year suspension for entering a closed area without proper authorization and a \$55.00 fine since that is the greatest of the three violations.
- 2nd offense** - The same individual is caught (after serving his NOVAA suspension for the previous offense) in possession of a gun/bow after legal hunting hours the charge in the suspension booklet (1 year) is doubled to 2 years and fined \$55.00.
- 3rd offense** - The same individual is caught transporting live wildlife. This normally carries a 1 year NOVAA and a \$55.00 fine. Since its his third offense he receives an automatic 5 year suspension from the Eglin reservation and a \$55.00 fine.

Note: Charges are not stacked. The violator is given the most severe of multiple violations.

Note: Monetary fines listed in this booklet can't be altered. Second time offenders fines cannot be doubled.

Note: Based on the severity of the offense and the blatant disregard for the rules some individuals may be given a life time ban from the Egin reservation
