### Special Opportunity Hunt



**Hunt Dates:**  
**08 - 09 February 2025**

Eligibility	<ul style="list-style-type: none"> <li>Applicants must meet the FWC <u><b>Mobility Impaired Certification</b></u> requirement and have a state mobility impaired certification.</li> <li><b>Applications submitted by individuals with past or current NOVAAs will be reviewed for eligibility.</b></li> </ul>
Applicants	<ul style="list-style-type: none"> <li>Applicants may be accompanied by one able-bodied, <u>non-hunting</u> assistant who must remain with the applicant at the stand site during the hunt.</li> <li><b>Any applicant whose name appears on multiple applications will be removed from the lottery.</b></li> </ul>
Application Period <b>1 Sept. - 31 Dec. 2024</b> <b>DO NOT e-mail or fax</b>	<ul style="list-style-type: none"> <li><b>Application must be mailed or returned in person to the Natural Resources Office within the Application Period.</b> The NRO is not responsible for applications lost in the mail.</li> <li>The NRO will not accept mailed applications arriving after the due date.</li> <li>Incomplete or illegible applications will not be entered in the lottery.</li> </ul>
Drawing <b>07 Jan. 2025</b>	<ul style="list-style-type: none"> <li>A random drawing will select 50 applications to participate in the 2-day hunt.</li> <li>Alternates will be drawn as replacements if a selected hunter cannot hunt.</li> </ul>
Drawing Notification  <b>08 Jan. 2025</b>	<ul style="list-style-type: none"> <li>Applicants can view hunters selected for the hunt by checking <i>eglin.iSportsman.net</i> under the <b>Special Opportunity Hunts/Events</b> heading, select the <b>Mobility Impaired Hunt</b> from the drop-down menu. Hunters selected will be identified by the following information provided from their application:           <ol style="list-style-type: none"> <li>1) First initial of first and last name</li> <li>2) Mobility Impaired Certification Number</li> <li>3) Last three digits of phone number</li> </ol> <div style="border: 1px solid black; padding: 2px; display: inline-block; margin-left: 20px;">Example: BM / 123456 / 145</div> </li> <li><b>Drawing results WILL NOT be available over the phone.</b></li> </ul>
Confirm Acceptance by <b>15 Jan 2025</b>	<ul style="list-style-type: none"> <li><b>Applicants selected but not confirming their slot by COB on the established date will forfeit their slot to the first available alternate.</b></li> </ul>
Cost of Hunt  <b>\$25.00 per hunter</b>	<ul style="list-style-type: none"> <li>Selected applicants can purchase their Sp. Opp. Hunt Permit the week prior to the hunt.</li> <li>Applicants must provide a photo ID and Mobility Impaired Certificate at time of permit purchase.</li> <li>Selling or transferring permits is prohibited.</li> <li><b>A \$5 FWC deer permit is required for all applicable hunters. Non-resident hunters will need to purchase (at minimum) a \$46.50 Florida 10-day non-resident hunting permit as well (not sold at Jackson Guard).</b></li> </ul>
Pre-Hunt Meeting  <b>07 Feb. 2025</b>	<ul style="list-style-type: none"> <li>Pre-hunt meeting will be at Jackson Guard @ 4:00 p.m. CST.</li> <li><b>Please arrive 30 minutes early to allow time to purchase permit.</b></li> <li><b>MANDATORY for every selected applicant.</b> Non-hunting assistant encouraged to also attend.</li> <li>Meeting will cover the special opportunity hunt rules, procedures, schedules, and answer any questions.</li> <li>All hunting rules and regulations for the State of Florida and Eglin AFB apply to this hunt.</li> </ul>
Legal to Take	<ul style="list-style-type: none"> <li>Antlered deer must have 3 points (<math>\geq</math> 1 inch in length) on a side or a main beam length of 10 inches or greater.</li> <li>Antlerless deer without antlers or antlers less than 5 inches in length (<u>NO spotted fawns</u>).</li> <li>Wild Hog and Coyote</li> </ul>
Bag Limits (per hunter)	<ul style="list-style-type: none"> <li>2 antlered deer or 1 antlered and 1 antlerless. <b>Harvested deer count toward the FWC's 5 deer statewide annual limit per hunter.</b></li> <li><b>FWC's deer harvest reporting requirements must be followed.</b></li> <li>No limit on wild hog or coyote.</li> </ul>
Hunt Locations	<ul style="list-style-type: none"> <li>A Jackson Guard escort is required when travelling to and from your hunt location.</li> <li>Hunters must stay at their assigned hunt location; safety protocol prohibits moving around without your guide.</li> </ul>
Check Station Requirement	<ul style="list-style-type: none"> <li>All harvested game must be checked at the Check Station.</li> <li>All hunters must check out with their Jackson Guard escort when leaving for the day.</li> </ul>
